## DC Ward Data at a Glance

The Census Bureau has now released its first five-year (2005-2009) data from the American Community Survey (ACS), and it contains information on the characteristics of the population of the District eight wards. This release is based on sample data collected over the course of the 2005 through 2009 calendar years (not an average of the five individual years) and it provides data on the socioeconomic, housing, and demographic characteristics of the nation and states, down to the block group level. The District of Columbia's ward characteristics are included as part of the State Legislative District (SLD) products. The data provided are not from the 2010 Census which will be released on a phased basis beginning in December 2010. However, both the ACS and the census data are collectively important components of the nation's information infrastructure, providing data that are essential to our economy, communities and neighborhoods.

Focusing on the population's characteristics, the ACS complements, but is different from, the 2010 Census population data. As a complete count of the population, the 2010 Census data are critical for people who need to know how many people live in the United States and where they live. The ACS data, on the other hand, are based on a sample survey of the nation and describe how we live by providing estimates of key social and economic characteristics.

## What is the American Community Survey?

The American Community Survey (ACS) is the successor to the former census "long form" that historically produced demographic, housing and socioeconomic data for the nation as part of the once-a-decade census. The decennial census program, which includes the ACS and the 2010 Census, serves as the basis for the allocation of more than \$400 billion in federal funds to state, local and tribal governments every year. These vital data also guide planning in the private sector as well as the work done by policymakers at all levels of government and in communities of all sizes. All survey responses are strictly confidential and protected by law.

The ACS samples nearly 3 million addresses each year, resulting in nearly 2 million final interviews. The annual ACS sample is smaller than that of the Census 2000 long-form sample, which included about 18 million housing units. As a result, the ACS needs to combine population or housing data from multiple years to produce reliable numbers for small counties, neighborhoods, and other local areas. To provide information for communities each year, the ACS will provide 1-, 3-, and 5-year estimates. ACS data are very timely because they are released in the year immediately following the year in which they are collected. Starting with the data collected in 2005, ACS information has been published for areas with populations of 65,000 or more. In the fall of 2008, the first 3-year estimates were released based on data from the 2005, 2006, and 2007 surveys. In December 2010, the ACS provided the first 5-year estimates of demographic, housing, social, and economic characteristics for the nation, states, cities, counties, and other small geographic areas. These 5-year estimates will be updated annually by removing the earliest year and replacing it with the latest one, and will provide, for the first time, the ability to monitor social and economic trends in local communities.

As is the case with all surveys, statistics from sample surveys are subject to sampling and nonsampling errors. All comparisons made in the reports have been tested and found to be statistically significant at the 90 percent confidence level, unless otherwise noted.
