


WHAT IS THE SAINT ELIZABETHS-CONGRESS HEIGHTS ECODISTRICT?

The St. Elizabeths-Congress Heights EcoDistrict aims to build upon the success of the Sustainable DC Plan <http://www.sustainabledc.org/about/sustainable-dc-plan/> and move beyond individual projects and building-level efforts to create a healthy, active, vibrant and sustainable community that will serve as a model for other Washington, D.C. neighborhoods. The St. Elizabeths-Congress Heights EcoDistrict represents a multi-agency effort to implement innovative projects that will support an economically vibrant, socially equitable, and environmentally responsible Congress Heights community. The Congress Heights neighborhood is undergoing many changes including the redevelopment of St. Elizabeths. To ensure that existing residents benefit from these changes, the District government has formed a multi-agency St. Elizabeths-Congress Heights EcoDistrict to implement existing plans and public projects in a way that furthers neighborhood scale sustainability – that is, achieving better environmental, economic and social outcomes.

WHAT IS AN ECODISTRICT?

An EcoDistrict is equitable, environmental, and economic sustainability applied at the neighborhood scale. EcoDistricts provide a framework for realizing a healthier and greener neighborhood– increasing efficiencies, reducing pollution, restoring ecosystems, and improving communities – through behavior change, building design, and infrastructure investments. EcoDistricts commit to achieving ambitious sustainability performance goals, guiding public investments and community action, and tracking the results over time. Fundamentally, EcoDistricts are an effort to deploy high-impact, or larger -scale sustainable projects that drive experimentation and innovation.

OVERVIEW & MISSION

Sustainable DC is the District of Columbia's plan to make DC the greenest, healthiest and most livable city in the county. Sustainable DC is working to create green jobs, healthier people, and more equitable neighborhoods in every part of the city. To help get out the word about sustainability across the District, Sustainable DC has launched a volunteer program called Sustainable DC Ambassadors where neighborhood residents talk to their neighbors, community groups, and businesses. Every ward has local representatives going out to community events in the spring through fall, you may see your Ward 8 reps at upcoming events such as the Congress Heights Senior Wellness Day.

To meet the goals of the Sustainable DC Plan, Washington, D.C. has joined the 'Target Cities Initiative', a two-year pilot program to create new models for sustainable neighborhood revitalization through innovative projects called 'EcoDistricts'. The EcoDistrict will identify priority project and sets goals relative to eight categories: 1) Equitable Development; 2) Health & Well-Being; 3) Habitat & Ecosystem Function; 4) Materials Management; 5) Community Identity; 6) Access & Mobility; 7) Energy; and 8) Water.

Starting in Fall 2015 and continuing through 2016, the initiative will host community activities and events around Congress Heights to take action on sustainability issues. Community engagement and active public participation are fundamental to the ongoing success of the EcoDistrict and to ensure the creation and implementation of a shared community vision that reflects neighborhood priorities.
